Re: Appointment of Devyani Khobragade as Ambassador of India to the Kingdom of Cambodia

Dear Deputy Prime Minister Prak,

We, the undersigned human rights and civil society organizations, are deeply concerned that Devyani Khobragade has been named as the next Ambassador of India to the Kingdom of Cambodia. Ms. Khobragade previously served in the United States as the Deputy Consul General of India. On March 14, 2014, federal authorities indicted her for alleged visa fraud and making false statements in connection with the mistreatment of her domestic worker. She is currently under indictment in the Southern District of New York. U.S. authorities consider her a fugitive.

According to the 2014 criminal indictment, Ms. Khobragade allegedly made false statements to U.S. authorities to obtain a visa for her domestic worker and then failed to pay the worker in accordance with U.S. minimum wage standards. Ms. Khobragade allegedly forced her domestic worker to toil long hours for approximately \$1.22 per hour and confiscated her passport, in violation of U.S. federal laws. Although the initial indictment did not charge Ms. Khobragade with human trafficking, all U.S. federal reporting subsequently has characterized the matter as a trafficking case.²

Indian government officials insisted—erroneously—that Ms. Khobragade enjoyed full diplomatic immunity as a consular officer. Ms. Khobragade was granted full diplomatic

immunity following her indictment and allowed to depart the United States. Ms. Khobragade is subject to arrest upon her return to the United States.

The Government of India, far from holding their diplomatic personnel accountable, has unacceptably elevated Ms. Khobragade to the status of Ambassador. It is an affront to the dignity of the Kingdom of Cambodia, and an affront to the dignity of Ms. Khobragade's victim, that Ms. Khobragade should receive this honor.

We implore the Government of the Kingdom of Cambodia to refuse *agrément* to the appointment of Ms. Khobragade. This would send a firm message that diplomats who allegedly engage in human trafficking and abuse of domestic workers, and who are under indictment for those alleged crimes, are not acceptable diplomatic appointments.
