Dear Speaker Pelosi and Chairman Scott,

The undersigned local, state and national organizations urge you to further advance the Domestic Workers Bill of Rights (H.R. 4826), including by holding a mark-up in the Education and Labor Committee and scheduling a vote in the House of Representatives. H.R. 4826 is led by Congresswoman Pramila Jayapal (WA-07) in the House with an identical Senate companion (S.2569) led by Senator Kirsten Gillibrand (NY) and Senator Ben Ray Luján (NM). H.R. 4826 has garnered 135 cosponsors in the House, since its original introduction in the 116th Congress.

First, we would like to thank the House for holding a hearing on H.R. 4826 in the Education and Labor Committee's Workforce Protections Subcommittee on July 28, 2022, as well for holding the subcommittee hearing entitled "From Excluded to Essential: Tracing the Racist Exclusion of Farmworkers, Domestic Workers, and Tipped Workers from the Fair Labor Standards Act" on May 3, 2021. Both hearings brought to light the long-standing systemic racial and gender discrimination — which has been enshrined in law — regarding work done inside the home, such as cooking, cleaning, child care and elder care.

During the New Deal era, Congress excluded domestic workers, a workforce largely made up of Black workers at the time, from core workplace protections, such as the Fair Labor Standards Act (FLSA) and the National Labor Relations Act. Domestic workers remained entirely excluded from the FLSA until 1974, and continue to be excluded from other federal workplace laws, including the Occupational Safety and Health Act, Title VII of the Civil Rights Act of 1964 and the Family and Medical Leave Act.

Today, both this legacy and ongoing legal exclusions continue to shape the lives of domestic workers. Domestic workers are paid low wages, have few employer-provided benefits, and lack common workplace protections that are enjoyed by other workers in our economy. Given that the nature of domestic work is intimate and isolated, many workers are subject to sexual assault and harassment, and physical and verbal abuse. Low wages and poor job quality, in turn, impact their ability to take care of their families. Many domestic workers are the primary breadwinners for their households, yet are unable to afford the very care services they provide for other families

The Domestic Workers Bill of Rights is critically needed to ensure that the estimated 2.2 million domestic workers — who are overwhelmingly women and women of color — have strong protections, dignity and respect in the workplace to achieve economic security. This legislation will help this underpaid and undervalued workforce by reversing the historical and racist wrongs that systematically wrote domestic workers out of most workplace protections and by rewriting the outdated and unjust cultural norms that define work in the home as "help," or less than real work.

H.R. 4826 ends the remaining exclusions from overtime protections, ensuring domestic workers who are privately paid and live in their employers homes receive fair compensation and treatment. Furthermore, this bill will improve workplace protections — including ensuring that domestic workers have paid sick leave to take care of themselves or family members who are ill. It will also strengthen workplace harassment and discrimination protections and safety and health measures.

We urge you to take swift action on the Domestic Workers Bill of Rights, including holding a mark-up and a vote. We look forward to working with you to uplift low-income working families and to make our economy more inclusive and equitable.
